Privacy Policy for the Management of Personal Information.

This document describes the privacy policy of Dr Leonie White for the management of clients' personal information. The psychological service provided is bound by the legal requirements of the Australian Privacy Principles set out in the Privacy Act 1988 (Cth).

Relevant personal information about the current situation will be collected and recorded as part of providing psychological services. The information will assist in providing appropriate and thorough service. The information will be stored in a secure location. Psychologists are required to keep your file for a minimum of 7 years or, if clients are under the age of 18 at the time of treatment, until they are 25 years of age.

Client information

Client files are held in a secure filing cabinet that is only accessible to Dr Leonie White. The information on each file includes personal information such as name, address, contact phone numbers, medical history, and other personal information collected as part of providing the psychological service. Personal information may also be collected and held in a secure internet-based appointment scheduling program.

How clients' personal information is collected

A client's personal information is collected in a number of ways during psychological consultation. These include times when the client provides information directly to Dr Leonie White using hardcopy forms, correspondence via email, and when other health practitioners provide personal information to Dr Leonie White via referrals, correspondence and medical reports.

Consequence of not providing personal information

If a client does not wish for their personal information to be collected in a way anticipated by this Privacy Policy, Dr Leonie White may not be in a position to provide the psychological service to the client.

Purpose of holding personal information

A client's personal information is gathered and used for the purpose of providing psychological services, which includes assessing, diagnosing and treating a client's presenting issue. The personal information is retained in order to document what happens during sessions and enables the psychologist to provide a relevant and informed psychological service.

Disclosure of personal information

All personal information gathered during the provision of services will remain confidential except when:

1. it is subpoenaed by a court, or disclosure is otherwise required or authorised by law; or
2. failure to disclose the information would in the reasonable belief of Dr Leonie White place a client or another person at serious risk to life, health or safety; or
3. the client's, or consent of a parent or guardian who is legally authorised to act on their behalf, prior approval has been obtained to:
 - a) provide a written report to another agency or professional, e.g., a GP or a lawyer; or
 - b) discuss the material with another person, e.g. a parent, employer, health provider, or third-party funder; or
 - c) clinical consultation with another professional is required to provide better clinical services (identifying details will remain confidential); or
 - d) disclose the information in another way; or
 - e) disclose to another professional or agency (e.g., your GP) and disclosure of your personal information to that third party is for a purpose which is directly related to the primary purpose for which your personal information was collected.

A client's personal information is not disclosed to overseas recipients unless the client consents or such disclosure is otherwise required by law. Clients' personal information will not be used, sold, rented or disclosed for any other purpose.

In the event that unauthorized access, disclosure, or loss of a client's personal information occurs the psychologist will activate a data breach plan and use all reasonable endeavours to minimise any risk of consequential serious harm.

Requests for access and correction to client information

You may access the information in your file on request, subject to the exceptions in the Privacy Act 1988 (<https://www.legislation.gov.au/C2004A03712/latest/text>).

The psychologist may discuss the contents with them and/or give them a copy, subject to the exceptions in the Privacy Act 1988 (Cth). If satisfied that personal information is inaccurate, out of date or incomplete, reasonable steps will be taken in the circumstances to ensure that this information is corrected. All requests by clients for access to or correction of personal information held about them should be lodged with Dr Leonie White. These requests will be responded to in writing within 21 days, and an appointment will be made if necessary for clarification purposes.

Concerns

If clients have a concern about the management of their personal information, they may inform Dr Leonie White. Upon request they can obtain a copy of the Australian Privacy Principles, which describe their rights and how their personal information should be handled.
